All Breeds except Flat Coated Retrievers and Golden Retrievers need to bring their Breed club paperwork.

Mechanical wingers will not be used in the WCX Test.

RUNNING ORDER: Preference in taking entries will be given first to retrievers currently untitled in the Stake(s) entered, second to retrievers titled in the stake(s) entered, third to untitled dogs of breeds other than FC or Goldens, and fourth to titled dogs of other breeds. Goldens and Flat Coats will run first, followed by other breeds.

Leftover birds will be sold at cost after the test is complete.

All dogs entered in the CCA Event must be at least 18 months of age.

Other Instructions/Information: Bitches in season are not allowed on the WC/X grounds. Refunds will be made for bitches in season or injured dogs, if a veterinarian's certificate is provided to the Test Secretary no later than 10 days following the event. Bitches in season entered in the CCA event should notify secretary, and plan to be in the last group of the day, no matter when scheduled. No refunds for bitches in season on CCA entry.

Non-Flat Coat and Golden owners are responsible for handling the necessary paperwork for certificates and approval from the specific parent breed club.

Hotels/motels should be notified of dogs in your party. Rules change and no promise is made that these hotels allow doggie guests.

ATTIRE:

These tests are closely related to, and the rules are based on, field trials. Field trial clothing is desirable. Gunners will wear white shirts or jackets, and it is appropriate for handlers to wear white or light-colored clothing when bringing dogs to the line.
